RESOLUTION NO. 160-2016

RESOLUTION CALLING FOR AMENDMENTS TO THE NEW YORK STATE ELECTRONIC EQUIPMENT RECYCLING AND REUSE ACT AND URGING THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION TO EXPEDITE THE PROMULGATION OF RELATED REGULATIONS

WHEREAS, The New York State Electronic Equipment Recycling and Reuse Act (Act) was adopted by the State Legislature in 2010 in order to increase the proper recycling of e-waste by banning its disposal in a landfill, shift the financial cost of proper recycling of e-waste from local government to the industries manufacturing the devices that become e-waste thus reducing costs borne by local governments, and to provide a mechanism to inform and educate consumers on how and where to properly dispose of e-waste; and

WHEREAS, The Act was intended to create a mechanism where electronics manufacturers funded e-scrap recycling programs that are effective, continuous and reasonably convenient to all consumers across the state; and

WHEREAS, In practice, the system created by the ACT has allowed manufacturers to withdraw their financial support for e-waste collection systems once they have met their individual performance standard (goal) for a given year resulting in the disappearance of collection sites for consumers to utilize and withdrawal of their funding for e-scrap handling firms that are then forced to pass costs on to cash-strapped local governments; and

WHEREAS, While the Act has succeeded in significantly increasing electronics recovery and recycling in the state, the sheer quantity of the materials being turned in by businesses and consumers has far exceeded the funding made available from electronics manufacturers under the Act; and

WHEREAS, The issue is exacerbated by the fact that electronics sold today weigh much less than the obsolete CRT devices that make up approximately 70% of the weight of e-scrap generated; and

WHEREAS, The e-waste collection system implemented as a result of the act has been inconsistent with limited opportunities located in more rural areas leaving local municipalities to

develop and implement programs to properly handle e-waste; and

WHEREAS, The e-waste collection infrastructure and funding mechanism created as a result of the Act has proven to be insufficient, inconsistent, and unstable and as a result local governments and other collectors are faced with mounting expenses in properly handling e-waste especially due to the limited markets for cathode ray tubes (CRTs) and the cost of recovering heavy metals they contain in properly disposing of the CRT's; and

WHEREAS, The Act empowers the DEC to promulgate regulations that could address many of the shortcomings in the law, and in October 2015 DEC officials indicated that such rules were being drafted by department officials; and

WHEREAS, The Environmental Quality Committee has reviewed the growing financial burden being placed upon local municipalities as a result of the implementation of the Act and recommends adoption of this resolution; and

RESOLVED, That the Ontario County Board of Supervisors calls upon Governor Andrew M. Cuomo, the New York State Assembly, the New York State Senate and the State Department of Environmental Conservation to improve the current law intended to create a more stable and comprehensive manufacturer implemented and funded electronics recycling infrastructure; and further

RESOLVED, That the Ontario County Board of Supervisors calls on state lawmakers to help alleviate the financial and administrative burden on municipalities who are dealing with e-waste and implement actions to strengthen communication among stakeholders, clarify key statutory provisions in their present rulemaking efforts, and promote the adoption of changes to the Act that will provide for year round, no-cost collection of electronics, make them consistently available in rural and metropolitan areas, and that help alleviate the immediate financial pressures faced by local governments; and further

RESOLVED, That certified copies of this resolution be sent to Governor Andrew Cuomo, Senate Majority Leader John Flanagan, Assembly Speaker Carl Heastie, Assembly Minority Leader Brian Kolb, Senator Michael Nozzolio, and Senator Rich Funke.

RESOLUTION NO. 161-2016

SUPPORT FOR BASE AID INCREASE FOR FINGER LAKES COMMUNITY COLLEGE

WHEREAS, Chancellor Zimpher of the State University of New York, with the support of the State University of New York Board of Trustees, has launched an advocacy plan across the State to “Stand with SUNY;” and

WHEREAS, Included in this “Stand with SUNY” initiative, is a request to increase base aid support for our community colleges in 2016-2017 by \$285/FTE; and

WHEREAS, The SUNY Board of Trustees, CUNY and SUNY Presidents’ Associations, Community College Trustees Association, SUNY Faculty Council, and others have expressed their support for this advocacy plan; and

WHEREAS, Recent base aid increases have not kept pace with ongoing increased costs of Finger Lakes Community College’s basic operations in spite of substantial staff and other operational reductions in recent years; and

WHEREAS, Finger Lakes Community College’s current (2015-2016) base aid, in spite of recent State increases, remains \$78/FTE lower than it was eight years ago and has not kept pace with mandated increases in health insurance and many other contractual obligations; and

WHEREAS, State support for community college operating budgets, currently at approximately 28.2% for Finger Lakes Community College with 2.1% of this percentage attributable to rental aid, is far below one-third of our operating costs or 40% for those with full opportunity access that all SUNY community colleges have embraced for decades (see Education Law Article 26, Section 6304); and

WHEREAS, As the local sponsor of Finger Lakes Community College, Ontario County finds it difficult to support our community college to the extent that we would like due to the limitations imposed by the property tax cap and other financial costs associated with State and Federal mandates; and

WHEREAS, Ontario County recognizes that Finger Lakes Community College is a vital part of the overall economic and workforce development of our region; and

WHEREAS, Our ability to continue to attract and grow business in our region is dependent on an educated and qualified workforce that is provided in large part by Finger Lakes Community College; and

WHEREAS, all these circumstances for our SUNY community colleges and their respective county sponsors are similar throughout the SUNY system; now, therefore, be it

RESOLVED, For all of these reasons, the Ontario County Board of Supervisors requests that the New York State Legislature and Governor Cuomo support a \$285/FTE base aid increase for SUNY’s community colleges.
