### CALL TO ORDER

The meeting of the Public Safety Committee was called to order at 11:00 a.m. by Chairman Green.

### MINUTES

Supervisor Bendzlowicz made a motion to approve the minutes of the Public Safety Committee meeting from December 12, 2016. Supervisor Ingalsbe seconded the motion. The motion carried.

### District Attorney

- ♦ **Budget Transfer :** Appropriation of Federal Crime Proceeds Reserve  
Supervisor Bendzlowicz made a motion to approve the budget transfer to provide the opportunity for the first assistant District Attorney to attend the annual conference in New York City in January. No tax dollars will be used. Supervisor Ingalsbe seconded the motion. The motion carried.

### STOP DWI

- ♦ **Resolution:** Acceptance of Grant from NYS Stop-DWI Foundation  
Supervisor Campbell made a motion to block the three STOP-DWI resolutions. Supervisor Bendzlowicz seconded the motion. The motion carried. This grant helps fund the holiday crackdowns over the course of the year.
- ♦ **Resolution:** Appointment to Traffic Safety Board  
This appointment is for Ms. Heidi Barend-Guerrie
- ♦ **Resolution:** Re-Appointments to Traffic Safety Board  
This appointment is for Mr.'s Tantillo, Duserick, Herren, and Ms. Beer

## PROBATION

- ♦ **Resolution:** 2017 FLACRA Contract Day Reporting Treatment Groups and Programming  
Supervisor Ingalsbe made a motion to approve the 2017 FLACRA contract for the day reporting treatment groups and programs. Supervisor Campbell seconded the motion. The motion carried.

Director Rougeux let the committee know that the day reporting program attendance numbers are going up. Supervisor Campbell asked how big the groups are. Director Rougeux says the groups tend to be 10-15 people at a time and are easily handled by FLACRA; the more people attending is a benefit to the county.

## Emergency Management

- ♦ **Invoice:** FL Communications # 102003482-1 for \$1,893.90  
Mr. Harloff informed the committee these invoices are for parts and installation of interoperability equipment these items and installation are done on state bid. Supervisor Bendzlowicz made the motion to approve the invoices as a block. Supervisor Campbell seconded the motion. The motion carried.

- ♦ **Invoice:** FL Communications # 102003484-1 for \$19,166.50

## Office of Sheriff

- ♦ **Resolution:** Contract to Provide Three Full-Time Deputies On Site at Eastview Mall  
Sheriff Povero explained that this contract is a renewal of the annual contract that we have with Eastview with an increase of 3% this year.
- ♦ **Resolution:** Intermunicipal Agreement Enhanced Law Enforcement Services - Town of Victor  
This contract will provide an additional 15 hours per week for enhanced traffic enforcement.
- ♦ **Resolution:** Intermunicipal Agreement Enhanced Court Services with Town of East Bloomfield  
This contract will provide 8 hours a month of court security for the Town of East Bloomfield.
- ♦ **Budget Transfer :** Appropriation of Crime Proceeds Reserve  
This is money that was seized from a detainee's case and will be transferred to finance to pay off items in the detainee's settlement case.

◆ **Renewal of Bid** : Uniform Cleaning

This is a renewal of the current contract.

Supervisor Campbell made the motion to approve the Sheriffs five aforementioned items as a block. Supervisor Bendzlowicz seconded the motion. The motion carried.

◆ **Update**: Position Requests

- The New York State Unified Court System is looking to add additional security for the new court room in the County courthouse. This will increase the contract from 11 FTE's to 13 FTE's.
- The Sheriff is also looking to create a Registered Professional Nurse (DBL) Position.
- Salary adjustment for a correction officer that will be moving to a police officer position.

◆ **Update**: Jail Population

- Currently there are 196 inmates at the jail with the female pod currently housing 47.
- Over the weekend there were 203 inmates.
- The jail has received a variance to bring back a few juveniles that were being housed out at Wayne County. This variance can be renewed every thirty days.

## DISCUSSION

- County Administrator Krause reported that Jim Ritts has been promoted to first assistant District Attorney. The request to have him be placed in the Management Compensation Plan along with a salary adjustment will be going to Ways & Means. His replacement will be coming soon.
- Sheriff Povero updated the committee on the heroin impact on the community. In 2016 there were 28 drug overdose related deaths in Ontario County more than triple the 8 in 2015. They are continuing education forums; also officers are now having to carry more Nar-Can due to the heroin being cut with more ingredients that are resistant to the Nar-Can.

On motion of Supervisor Campbell the meeting was adjourned at 11:32 a.m. Supervisor Ingalsbe seconded the motion. Motion carried.
