### CALL TO ORDER

The meeting of the Public Safety Committee was called to order at 11:00 a.m. by Chairman Green.

### MINUTES

Supervisor Campbell made a motion to approve the minutes of the Public Safety Committee meeting from February 8, 2017. Supervisor Venuti seconded the motion. The motion carried.

### CAMPBELL COMMISSION

Supervisor Campbell gave an update on the Campbell Commission. A couple of items they are working are restructuring their short, medium, and long term goals, and creating a Law Enforcement Advisory Counsel.

### PLANNING

- ♦ **Invoice:** Harris Corporation Invoice No. P000002000 for \$101,342.31 (CP 6-2015) Supervisor Bendzlowicz made the motion to approve the invoice for Harris Corporation. Supervisor Westbrook seconded the motion. The motion carried. This invoice is for the microwave equipment for the redundant network for the closing of the Geneva PSAP.
- ♦ **Invoice:** Insight Public Sector, Inc. Invoice No. 1100519498 for \$3,095.85 (CP 6-2015) Supervisor Bendzlowicz made the motion to approve the invoice for Insight Public Sector, Inc. Supervisor Ingalsbe seconded the motion. The motion carried. This invoice is for three LED monitors for the 9-1-1 center.

### OFFICE OF SHERIFF

- ♦ Appropriation of Reserve Funds Sheriff Povero asked to appropriate a portion of the wireless 9-1-1 fees to upgrade the storage system for 9-1-1 call recordings. Supervisor Bendzlowicz made the motion to approve the appropriation of reserve funds. Seconded by Supervisor

Campbell. The motion carried.

♦ **Resolution:** Acceptance of Bid for Purchase of Sheriff's Uniforms and Footwear

♦ **Resolution:** Renewal of Contract for Inmate Dental

♦ **Resolution :** Agreement for Art Therapy Program

This program is paid for out of the commissary account.

♦ **Resolution :** In Support of Housing NYS Administrative Parole Violators in NYS Department of Corrections Facilities

This resolution is asking for NYS to place their parole violators in the NYS correction facilities after 72 hours rather than county correction facilities or reimburse the counties for the housing of these persons. This support is for the Senate Bill 449. Currently there are 23 parole violators being held at our corrections facility.

Supervisor Venuti made the motion to approve the Sheriffs four aforementioned items as a block. Supervisor Ingalsbe seconded the motion. The motion carried.

♦ **Update:** Jail Population

- Currently there are 188 inmates at the jail.
- Over the weekend there were 205 inmates.
- During the month of January upon admission to the jail:
  - 176 persons admitted to having a drug issue/addiction
  - 93 persons admitted to having a mental health issue

## DISCUSSION

- County Administrator Krause informed the committee that she is working with others to get the time frame for receiving civil service test result back decreased as it is currently about 15 weeks.
- County Administrator Krause recently went to Drug Court and Veterans Court. It was great to see all the county departments at work and the positive things they do.
