#### **PUBLIC HEALTH**

◆ *Update* 

Public Health Director, Mary Beer, presented the following COVID-19 updates:

- 5845 Total positive cases since we started tracking
- 25 New cases today
- 176 In isolation
- 329 In Quarantine
- 23 in the hospital
- The 13<sup>th</sup> of march will be the 1 year anniversary of the first COVID case in Ontario County
- The Johnson and Johnson vaccine will be coming soon
- The State Fair site will be opening 24/7 soon with the Johnson and Johnson vaccine

Ms. Adams presented a resolution to set the public hearing for Local Law 1 (Intro.) of 2021.

Supervisor Vedora motioned to approve the setting of the public hearing for Local Law 1 (Intro.) of 2021. Supervisor Wille seconded the motion. The motion carried.

Discussion ensued with many questions still needing some more research. This research will be brought back to committee next cycle.

Mr. Baker noted that the restaurants are varied if they like this Local Law. As the law is written the restaurant would have to work out the fees with the deliver companies, and then decide if they want to use the service or not.

Ms. Menikotz asked if the executive order has been enforced? Mr. Baker noted that the owner of simply crepes and another restaurant can't get through to DoorDash and Grubhub to let them know and about the executive order and to adjust the fees.

Ms. Knoblauch talked to a restaurant marketing director in Rochester who has spoken to Grubhub about the fees. They stated that a restaurant can apply to get fees back that are outside a Local Law or executive order.
